MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE TRI-STATE FIRE PROTECTION DISTRICT HELD 20, JUNE 2016 AT DISTRICT #3.

I. CALL TO ORDER

The meeting was called to order at 1830 hours by Trustee Habercoss. On roll call:, Trustee Habercoss, Trustee Wolski, Trustee Jewell, Acting Chief Brenn, Attorney Wargo, Attorney Ottosen and Admin Asst Radek.
Pledge of Allegiance

II. MINUTES

Trustee Habercoss made a motion to accept the minutes from 17, May 2016, Trustee Wolski seconded the motion. Motion approved 2-0-1.

III. TREASURER'S REPORT

Trustee's Wolski and Habercoss asked to table the approval of the treasurer's report as they have not had time to review the report.

IV. NEW BUSINESS

Resolution authorizing Tri-State Fire Protection district to enter into an IGA with the Village of Addison for the leasing of our dispatch facility for police and fire dispatching until the new facility in Addison is built. Trustee Habercoss made a motion to approve Resolution 2016-R-007 pending attorney approval, motion seconded by Trustee Jewell. Motion approved by roll call vote, Habercoss – Aye, Wolski – Aye, Jewell – Aye. 3-0-0.

PAGE TWO MINUTES OF THE BOARD OF TRUSTEES 20, JUNE 2016

Les Peach from the Horton Group presented our renewal package for vehicle and building coverage. Discussions regarding an increase in our rates due to the increase of our claims. It was suggested to increase our deductibles as the current deductibles are extremely low causing an increase in premiums. If Tri-State can have a claim free year, our insurance rates should show a dramatic decrease for FY 18.

Trustee Habercoss made a motion to approve an Ordinance to bill for open burning and nuisance fires and setting fees for such violations. Trustee Jewell seconded the motion. Motion approved by roll call vote, Habercoss – aye, Jewell – Aye, Wolski – Aye. 3-0-0.

Trustee Habercoss made a motion to approve a resolution to approve and ratify execution of the settlement agreement between the District and former employee Lisa Panock. Trustee Wolski seconded the motion, Motion approved by roll call vote, Habercoss – Aye, Jewell – Aye, Wolski – Aye, 3-0-0.

Trustee Habercoss made a motion to approve a letter of intent to participate in the DuPage Judicial Information System. It is a 2-year commitment with police absorbing a large portion of the cost. Fire will pay for connection \$38,000/4. CAD will work with alerting service. Trustee Jewell seconded the motion. Motion approved by roll call vote, Habercoss – aye, Wolski – Aye, Jewell – aye. 3-0-0.
