C. Discussion and possible action regarding the amount to be financed through PNC Financing in order to purchase a new 2021 Pierce Ascendant Ladder Truck. Deputy Chief Brenn explained the lease/finance agreement to the Trustees with a purchase option in the seventh (7<sup>th</sup>) year.

Motion by Wolski, second by Scarpelli to approve moving forward with the lease/purchase financing through PNC Financing not to exceed \$1,200,000.00 Roll call vote: Scarpelli Aye, Mensinger Aye, Wolski Aye. 3-0-0.

D. Attorney Wargo discussed requesting a 10.8% increase in the levy for the upcoming fiscal year. The need to conduct a truth in taxation hearing at an upcoming meeting, and to publically publish a notice regarding that hearing in a publication which is available to the residents of the district, and the legal timelines for publication were explained. Attorney Wargo also suggested that due to the unknown possible effects of the pandemic regarding holding public meetings, that a special meeting be held before the December 21st regular scheduled meeting.

Motion by Mensinger, second by Scarpelli to move forward with holding a special meeting on December 9, 2020 to hold a truth in taxation hearing regarding a proposed 10.8% increase to the upcoming tax levy.
