ORDINANCE NO. 2024-O-005

**ORDINANCE LEVYING AND ASSESSING TAXES OF
THE TRI-STATE FIRE PROTECTION DISTRICT
DUPAGE AND COOK COUNTIES, ILLINOIS FOR 2024**

BE IT ORDAINED by the Board of Trustees of the Tri-State Fire Protection District, DuPage and Cook Counties, Illinois, as follows:

Section One: That the sum of FIFTEEN MILLION NINE HUNDRED THIRTY-SIX THOUSAND SEVEN HUNDRED FORTY DOLLARS AND ZERO CENTS (\$15,936,740) be assessed and levied from and against all taxable property within the limits of the said Tri-State Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2024. The specific amount hereby levied is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:

AMOUNT TO BE RAISED BY TAX LEVY:

CORPORATE FUND

Corporate Fund Levy \$7,019,480.00

The foregoing amount is hereby levied for general corporate purposes pursuant to the provisions of 70 ILCS 705/14.

AMBULANCE FUND

Ambulance Fund Levy \$5,743,212.00

The foregoing amount is hereby levied for ambulance expense purposes pursuant to the provisions of 70 ILCS 705/22.

FIREFIGHTER PENSION FUND

Firefighter Pension Fund Levy \$2,096,725.00

The foregoing amount is hereby levied for firefighter pension fund purposes pursuant to the provisions of 40 ILCS 5/4-118.

FIREFIGHTER PENSION FUND (P.A. 93-0689)

Additional Firefighter Pension Fund Levy (P.A. 93-0689) \$182,323.00

The foregoing amount is hereby levied for pension fund purposes pursuant to 40 ILCS 5/4-118 and the provisions of Public Act 93-0689 and exempt from the limitations imposed under the Property Tax Extension Limitation Law.

FICA FUND

FICA Fund Levy \$185,000.00

The foregoing amount is hereby levied for FICA fund purposes pursuant to the provisions of 40 ILCS 5/21-110.

TORT IMMUNITY FUND

Liability Immunity Fund Levy \$666,000.00

The foregoing amount is hereby levied for tort immunity purposes pursuant to the provisions of 745 ILCS 10/9-107.

IMRF FUND

IMRF Fund Levy \$20,000.00

The foregoing amount is hereby levied for Illinois Municipal Retirement Fund contribution and withholding purposes to the provisions of 40 ILCS 5/7-171.

AUDIT FUND

Audit Expense Fund Levy \$24,000.00

The foregoing amount is hereby levied for audit expense purposes pursuant to the provisions of 50 ILCS 310/9.




